

# Notice about the Child-Rearing Support Allowance in Response to Rising Prices

**This allowance will, in principle, be paid automatically to all eligible individuals. Please be sure to confirm whether you still need to apply!**

**Starting at the end of February, a one-time allowance of 20,000 yen per child will be paid.**

## **1. Those who are eligible for the allowance**

- (1) Parent/guardian who received child allowance **for the September 2025 period for their child**
- (2) One of the parents/guardians rearing a child born between September 1, 2025 **and March 31, 2026**, whichever has the higher income
- (3) Parent/guardian who became eligible for child allowance due to divorce (including an ongoing divorce agreement process or the like) in September 2025 or later

## **2. Those who need to apply**

**In principle, you need to apply if any of the following conditions apply:**

- If you are a **government employee** and are receiving child allowance from the government agency for which you work (Please consult your government agency regarding the procedure.)
- **If you fall under condition 1-(2) above but applied for child allowance in January 2026 or later, or if you fall under condition 1-(3) above**

## **3. Application deadline**

**March 31, 2026** (or April 15, 2026 for children born in March 2026)

## **4. Allowance amount**

**One-time allowance of 20,000 yen per eligible child**

## **5. Payment method**

- (1) If you are a child allowance recipient  
The child-rearing support allowance will be paid via bank transfer to **the account you used to receive the child allowance in October 2025 or that you have registered by submitting a notification.**
- (2) If you apply for the child-rearing support allowance  
The allowance will be paid via bank transfer to **the account you specify in the application form.**

## **6. Time of payment**

- If you do not need to apply → **Payment will be made at the end of February.**
- If you need to apply → **Payment will be made from the end of March to the end of April.**

**7. If you wish to decline the child-rearing support allowance in response to rising prices or to receive it via a different bank account**

Please submit a notification by **February 24, 2026**. (Notification by post must reach us by this date.)

**8. If you moved to Miyazaki City in October 2025 or later**

**You will receive the allowance via bank transfer from the municipality from which you received the child allowance for the September 2025 period.**
